

COVID-19 Vaccination or Exemption Declaration

The Rail Industry Worker (**RIW**) Program is operated by Metro Trains Australia Pty Ltd (**MTA**). This declaration outlines specific requirements regarding an RIW cardholder's ability to demonstrate COVID-19 vaccination or exemption status which will assist with RIW cardholders being able to access worksites. This declaration is to be read in addition to the other terms and conditions that govern the RIW Program, including the <u>Permission Access Agreement</u> and <u>MTA's Privacy Policy – RIW Program</u>.

COVID-19 Vaccination or Exemption Certificate Declaration Terms

I agree:

- 1. That the COVID-19 vaccination or exemption certificate supplied is accurate and complete and has not been modified, altered or tampered with in any way.
- 2. That the information provided in the declaration above is accurate based on the COVID-19 vaccination or exemption certificate that has been sited and verified with this declaration.
- To the collection, use and disclosure of this declaration by RIW Participants to determine whether I am permitted access to a worksite or for any other reason required or authorised by law.
- **4.** To the disclosure of information stored on the RIW System to transport safety regulators, other regulatory bodies, government departments or as otherwise required to comply with applicable laws or regulatory requirements.
- 5. That in some areas access to worksites may be restricted based on COVID-19 vaccination or exemption status.
- 6. For this declaration to be uploaded into the RIW System to enable it to be viewed by an RIW's Employer, an RIW Participant that an RIW is connected via swiping onto a worksite or associated with in the RIW System, a site access controller, an authorised health professional or a registered training organisation.
- 7. To notify the RIW Service Desk of any changes which may affect the accuracy of the information on the RIW System, including this declaration, so that they can update the information on the RIW System if needed.
- 8. To comply with all applicable work procedures and requirements set by law or by a relevant RIW Participant, including all requirements relating to competency, fatigue management, drug and alcohol use, health and fitness and COVID-19.
